- **Font Size:** 12 (main text), 10 (footnotes)
- **Line Spacing:** 1.5 (main text), 1.0 (footnotes)
- **Citation Style:** *OSCOLA 4th Edition*
- **File Format:** Word file or Pdf

- **Single Author:** ₹250
- **Co-authorship (maximum 2 authors):** ₹450
